

# **Boditech/Immunostics Privacy Policy**

## **I. Introduction**

When you use services Boditech/Immunostics Inc., ("**Company**" or "**We**") provide, you will share some information with us. In addition, we must receive or collect some information from you to operate, provide, improve, understand, customize, support, and market our services, including when you install, access, or use our services. Thus, we want to be upfront about the information we collect, how we use it, whom we share it with, and the controls we give you to access, update, and delete your information. We respect your privacy and are committed to protecting it through our compliance with this policy. This policy describes:

- The types of information we may collect or that you may provide when you download, install, and/or access, or use the **RAPIDCHECK™** (the "**App**").
- Our practices for collecting, using, maintaining, protecting, and disclosing that information.

This policy applies only to information we collect in this App and in email, text, and other electronic communications sent through this App.

This policy DOES NOT apply to information that:

- We collect offline or on any other Company apps or websites, including websites you may access through this App.
- You provide to or is collected by any third party.

Our websites and apps, and these other third parties may have their own privacy policies, which we encourage you to read before providing information on or through them.

Please read this policy carefully to understand our policies and practices regarding your information and how we will treat it. If you do not agree with our policies and practices, do not download, register with, or use this App. By consenting to it downloading, registering with, or using this App, you agree to this privacy policy. This policy may change from time to time. If there are material changes to the Policy or in how we will use your personal information, we will notify you either by prominently posting a notice of such changes before they take effect or by directly sending you a notification. We encourage you to periodically review this Policy to learn how we are protecting your information and privacy.

## **II. Children Under the Age of 14**

The App is not intended for children under 14 years of age, and we do not knowingly collect personal information from children under 14. If we learn we have collected or received personal information from a child under 14 without verification of parental consent, we will delete that information. ## **III. Information We Collect and How We Collect It**

We collect information from and about users of our App:

- Directly from you when you provide it to us.
- Automatically when you use the App.

#### A. Information You Provide to Us

When you download, register with, or use this App, we may ask you provide information:

- By which you may be personally identified, such as ZIP code and any other identifier by which you may be contacted online or offline ("**personal information**").
- That is about you but individually does not identify you, such as medical information or other information provide through the usage of the App.

This information may include:

- Information that you provide by filling in forms in the App. This includes information provided at the time of registering to use the App and requesting further services. We may also ask you for information when you report a problem with the App.
- Records and copies of your correspondence (including email addresses and phone numbers), if you contact us.
- Your responses to surveys that we might ask you to complete for research purposes.
- Your search queries on the App.

You may also provide information for publication or display ("**Posted**") on public areas of websites you access through the App (collectively, "**User Contributions**"). Your User Contributions are Posted and transmitted to others at your own risk. Please be aware that no security measures are perfect or impenetrable. Additionally, we cannot control the actions of third parties with whom you may choose to share your User Contributions. Therefore, we cannot and do not guarantee that your User Contributions will not be viewed by unauthorized persons.

When you contact us for customer support or otherwise communicate with us, you may provide us with information related to your use of the App and any other information you deem helpful and to resolve any issues arise out of your use of the App.

#### B. Automatic Information Collection

When you download, access, and use the App, it may use technology to automatically collect:

- **Usage Details.** When you access and use the App, we may automatically

collect certain details of your access to and use of the App, including traffic data, location data, logs, and other communication data and the resources that you access and use on or through the App.

- **Device Information.** We may collect information about your mobile device and internet connection, including device's IP address, operating system, browser type, mobile network information, etc. but not the device's unique identifier and telephone number.
- **Location Information.** This App does not collect real-time information about the location of your device.

If you do not want us to collect this information do not download the App or delete it from your device.

### C. Information Collection Technologies

The technologies we use for automatic information collection may include:

- **Cookies (or mobile cookies).** A cookie is a small file placed on your smartphone. We may use cookies to collect information about your activity, browser, and device. It may be possible to refuse to accept mobile cookies by activating the appropriate setting on your smartphone. However, if you select this setting, you may be unable to access certain parts of our App.
- **Web Beacons.** Pages of the App may contain small electronic files known as web beacons (also referred to as clear gifs, pixel tags, and single-pixel gifs) that permit the Company, for example, to count users who have visited those pages and for other related app statistics (for example, recording the popularity of certain app content and verifying system and server integrity)

### D. Third-Party Information Collection

When you use the App or its content, certain third parties may use automatic information collection technologies to collect information about you or your device.

They may use this information to provide you with interest-based (behavioral) advertising or other targeted content.

We do not control these third parties' tracking technologies or how they may be used. If you have any questions about an advertisement or other targeted content, you should contact the responsible provider directly.

## How We Use Your Information

We use information that we collect about you or that you provide to us, including any personal information, to:

- Provide you with the App and its contents, and any other information, products

or services that you request from us.

- Fulfill any other purpose for which you provide it.
- Notify you when App updates are available, and of changes to any products or services we offer or provide through it.

The usage information we collect helps us to improve our App and to deliver a better and more personalized experience by enabling us to:

- Estimate our audience size and usage patterns.
- Enhance the safety and security of our services.
- Enforce, investigate, and report conduct violating our terms of service and other usage policies, respond to requests from law enforcement, and comply with legal requirements.

#### **IV. Disclosure of Your Information**

Safety, security, and integrity are an integral part of our services. We do not and will not sell personal information about our customers. We only disclose your data as described in this Policy. We may share information with the following types of third parties. We do not and will not sell your data to third parties.

In addition, we may disclose personal information that we collect or you provide:

- To our subsidiaries and affiliates.
- To fulfill the purpose for which you provide it.
- For any other purpose disclosed by us when you provide the information.
- With your consent.
- To comply with any court order, law, or legal process, including to respond to any government or regulatory request.
- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of the Company, our customers or others.

#### **V. Your Choices About Our Collection, Use, and Disclosure of Your Information**

We strive to provide you with choices regarding the personal information you provide to us. This section describes mechanisms we provide for you to control certain uses and disclosures of your information.

- **Tracking Technologies.** You can set your browser to refuse all or some browser cookies, or to alert you when cookies are being sent. If you disable or refuse cookies or block the use of other tracking technologies, some parts of the App may then be inaccessible or not function properly.

We do not control third parties' collection or use of your information to serve interest-based advertising. However, these third parties may provide you with ways to choose not to have your information collected or used in this way. You can opt out of receiving targeted ads from members of the Network Advertising Initiative ("**NAI**") on the NAI's website.

Where we are using your personal information on the basis of your consent, you are entitled to withdraw that consent at any time by contacting [technical@immunostics.com](mailto:technical@immunostics.com).

Where we process your personal information based on our legitimate interest and no opt-out mechanism is available to you on our website or App, you have the right to object at any time to that use of your personal information by sending an email to [technical@immunostics.com](mailto:technical@immunostics.com).

We will respond to your request within 30 days.

## **VI. Your California Privacy Rights**

If you are a California resident, California law may provide you with additional rights regarding our use of your personal information. You may opt out of all sales of your Personal Information. We never exchange Personal Information for money or any other consideration (e.g., trade it for free services).

California's "Shine the Light" law (Civil Code Section § 1798.83) permits users of our App that are California residents to request certain information regarding our disclosure of personal information to third parties for their direct marketing purposes. ## **VII. Data Security**

We have implemented measures designed to secure your personal information from accidental loss and from unauthorized access, use, alteration, and disclosure. All information you provide to us is stored on our secure servers behind firewalls.

The safety and security of your information also depends on you.

We use industry standard best practices to protect your personal information. Unfortunately, the transmission of information via the internet and mobile platforms is not completely secure. Although we do our best to protect your personal information, we cannot guarantee the security of your personal information transmitted through our App. Any transmission of personal information is at your own risk. We are not responsible for circumvention of any privacy settings or security measures we provide.

## **Retention**

We do not retain any of your personal information, but if you opt for reporting your results,

they are reported to [Makemytestcount.org](http://Makemytestcount.org), which may retain your information as a third party app.

## Your rights

You are allowed to obtain access to the personal data that we process and can make reasonable requests to correct, amend, delete, block, restrict information or object to particular ways in which we are using your personal information where it is inaccurate.

In the event you choose to delete or thoroughly anonymize your personal data from our database, we may retain a record of your deletion request as well as records indicating the type of information deleted as evidence of our compliance with this Internet Protection Notice.

You can also exercise your rights to obtain the portability of your personal data or to request the restriction of the processing of your personal data.

In addition, whenever we process your personal data based on its legitimate interest, you may at any time object to such processing on legitimate grounds relating to your particular situation.

We do not endorse, nor does it participate in the practice of “spamming” (sending of unsolicited promotional e-mail). If you believe you have received such a message from us, please contact [technical@immunostics.com](mailto:technical@immunostics.com)

You can delete the App at any time including if you want to revoke your consent to our use of your information pursuant to applicable law. When you delete the App from your device, we no longer operate your information and provide our service.
